## Terms & Conditions

These terms and conditions govern the **Succedo Trade 2.5% Cashback Promotion** (the "Promotion") available to existing & new account holders of **Winpro Ltd.** Succedo Trade operates under **Winpro Ltd**, located at **Ground Floor, The Sotheby Building, Rodney Bay, Gros-Islet, Saint Lucia, P.O. Box 838, Castries, Saint Lucia.** By participating in this Promotion, you agree to comply with these **Promotion Terms** in addition to the **Succedo Trade Customer Agreement** (including any applicable supplemental terms) that govern your account (**Our Terms**). In the event of any disputes, Succedo Trade's interpretation and decision shall be final and binding.

### 1. Eligibility and Promotion Duration

1.1. This Promotion is available exclusively to new account holders who successfully open an account for the first time or to existing customers who open a new account without any trading history. 1.2. Eligible account holders must opt into the Promotion within **30 days** of account opening. 1.3. Employees of Succedo Trade, their immediate family members, and individuals working with any partners, agencies, auditors, or advertising firms directly involved in the Promotion are not eligible. 1.4. Clients introduced via an **Introducing Broker (IB)** or **third-party affiliate** are **not eligible** for this Promotion. 1.5. The Promotion is limited to **one account per individual**. Multiple accounts from the same household may be disqualified. 1.6. The Promotion period spans the **first 45 calendar days** from account deposit. The date of the **deposit approval email** is considered as **Day 1**. 1.7. **Joint accounts** and accounts with a **Limited Power of Attorney (LPOA)** are **ineligible** for the Promotion. 1.8. Succedo Trade reserves the right to withhold cash back if there is any evidence of abuse, collusion, or fraudulent activity related to this Promotion. 1.9. Minimum \$10,000 deposit is required to qualify for this promotion.

### 2. Cashback Criteria & Funding Requirements

2.1. To qualify for the cashback, the following conditions must be met during the promotional period:

Succedo Trade is **not responsible** for any financial loss, technical issues, platform malfunctions, or connectivity failures related to this Promotion. 3.5. Succedo Trade reserves the right to **amend, suspend, or terminate** the Promotion at any time without prior notice. 3.6. All decisions made by Succedo Trade regarding this Promotion are **final and binding**. 3.7. Cashback earned may be **used for trading, margin coverage, or can be withdrawn**. 3.8. Cashback is calculated in **USD**. For **non-USD accounts**, the cashback will be converted to the account's base currency using **Succedo Trade's prevailing exchange rate** at the time of crediting. 3.9.
